### **Documentation: Overview**

#### Virtual

- All MARCQI surgeons who attended virtually must be identified on the screenshot(s) with legible virtual meeting IDs. If they are not present on the screenshot(s), they did not attend
- All MARCQI surgeons who attended virtually are part of your site account
  - If not, please complete this form to add the surgeon to your site so that they are able to obtain credit for their attendance
- Once the form is complete, please confirm the surgeon is on your site account before submitting
- Your agenda clearly notes the date of the meeting and site name
- The date on the agenda must match the date of the submission made on the MARCQI database
- Both the sign in sheet & agenda are in PDF format
- Please submit the meeting documentation via the MARCQI database as soon as you can so that your site's progress can be updated appropriately

#### **In-person**

- All MARCQI surgeons who attended in person printed and signed\* their name
  - \*Typed names and/or copy & paste signature are not accepted
- All MARCQI surgeons who attended in person are part of your site account
  - If not, please complete this form to add the surgeon to your site so that they are able to obtain credit for their attendance
- Once the form is complete, please confirm the surgeon is on your site account before submitting
- Your clinical champion has completed the attestation to the sign in sheet via physical signature
- Your agenda clearly notes the date of the meeting and site name
- The date on the agenda must match the date of the submission made on the MARCQI database
- Both the sign in sheet & agenda are in PDF format
- Please submit the meeting documentation via the MARCQI database as soon as you can so that your site's progress can be updated appropriately

Hybrid meeting? Both virtual and in-person documentation is required

## **Documentation: Previously shared FAQs**

- Outside of the clinical champion and CDA, is there minimum number of attendees needed to for the site-based QI meeting count?
  - We ask that there is at least one other person involved in joint-replacement surgery pre, peri, and post-operative care present to discuss the materials.
  - These could include quality directors, advanced practice providers, clinic/surgery coordinators, or other persons involved in total arthroplasties and orthopedics at the site
- Do we have to use the modified slide deck from the most recent collaborativewide meeting at our site-based QI meeting?
  - No, the modified slide deck is provided as a potential resource for sharing information from the collaborative-wide meeting if you choose to use it.
- What are the Clinical Champion's responsibilities during a site-based QI meeting?
  - $\circ\,$  Clinical Champions must attend the site-based QI meeting and sign off on the attendance/sign-in sheet for the meeting



### **Documentation: Previously shared FAQs**

- Do I need to turn in the checklist a part of my site-based QI meeting documentation?
  - $\circ$  No, please do not include the checklist as part of your site-based QI meeting documentation.
- Can a site-based QI meeting be both in-person and virtual at the same time?
  - Yes, hybrid meetings are accepted when documentation of each arm (e.g., in-person, virtual) is provided.
  - $\circ\,$  Both the in-person and virtual sign in sheets will need to be completed. One for the people inperson and the other for those who attended virtually.
- If a MARCQI surgeon missed the site-based QI meeting, can the Clinical Champion conduct another site-based QI meeting?
  - Yes, the site would need to submit a separate sign-in sheet and agenda for the additional meeting/s to be counted as a site-based QI meeting for the MARCQI surgeon



## **Documentation: Previously shared FAQs**

- Can a MARCQI surgeon attend site-based QI meetings at more than one site?
  - Yes, a MARCQI surgeon can attend site-based QI meetings at more than one site in a calendar year to count towards their 3 of 3 site-based QI meeting attendance to meet the VBR metric and ABOS MOC SAE credit.
  - The MARCQI surgeon must still attend at least 1 site-based QI meeting at a site at which they
    operate following each MARCQI collaborative-wide meeting in a calendar year to meet the 3
    of 3 site-based QI meeting attendance

#### • What is ABOS MOC SAE?

- The American Board of Orthopaedic Surgery (ABOS) Maintenance of Certification (MOC) committee approved active participation in MARCQI as an alternate choice for earning selfassessment examination (SAE) credits for the Board's MOC process.
- Each diplomate is able to receive 10 SAE credits for each year of MARCQI participation by attending 3 of 3 site-based QI meetings as an alternative to 10 scored and recorded SAE credits



### **Documentation: Standardization & practices**


### Why?

- To ensure all partners are aware of the expectations for documentation and the new process
- All reviewers follow the same guidelines and expectations to documentation received
- Quality assurance in submitted documentation
- Support correct data capture for surgeons that may operate across different sites
- Increase transparency for attendance-based metrics tracking
  - (e.g., Pay for Performance (P4P), Performance Incentive (PI), Value Based Reimbursement (VBR), American Board of Orthopaedic Surgery (ABOS) Maintenance of Certification (MOC) self-assessment examination (SAE) credits)



### **Clinical Champion attestation issues**

• Issue 1: Clinical Champion attestation date is prior to the date of the site-based quality meeting.



#### Reason:

Pre-signed forms are not accepted as attendance attestations for site-based quality meetings

#### Solution:

Clinical Champion must sign the day of the meeting or afterwards upon reviewing the sign-in sheet.



### **Clinical Champion attestation issues**

• Issue 2: Clinical Champion is not able to sign a paper version of the virtual meeting sign-in sheet.

#### • Solution:

- Forward a copy of the sign in sheet via email to the Clinical Champion's attention for review.
- Clinical champion will need to reply to email that they agree that:

   <u>Clinical Champion name</u>, as the MARCQI Clinical Champion at <u>Site</u> <u>name</u> confirm that the documented attendance for the meeting noted is accurate.
- Attach the email with to, from, and date of the message clearly displayed to the sign in sheet as a single PDF to use as a verified signature.



### **Clinical Champion attestation issues**

• Issue 3: Clinical Champion misses scheduled site-based quality meeting

#### • Reason:

- Meeting does not meet the attendance requirements for a site-based quality meeting and will not be accepted
- Required attendees of a site-based quality meeting are:
  - $\circ$  Clinical Champion
  - **o Clinical Data Abstractor**
  - ${\rm \circ}$  Another individual involved in joint replacement care

#### Solution:

• Reschedule the site-based quality meeting so that the Clinical Champion can attend with other required attendees


• Issue 1: Virtual meeting ID does not match the screenshot and provided documentation.

#### • Reason:

- Sites may be very familiar with everyone at their facility; however the coordinating center is not.
- Please help us by matching the IDs to the documentation exactly.

#### Solution:

• Ensure the sign-in sheet matches the screenshot shared EXACTLY.






• Issue 2: Unidentified meeting attendees on screenshot

#### Solution:

- Document the EXACT virtual meeting ID seen in the screenshot into the sign-in sheet.
- Clearly identify the person who attended by first and last name.





• Issue 3: Screenshot is not legible


• Issue 3: Screenshot is not legible

#### • Reason:

• Coordinating Center can not validate information shared in documentation

#### • Solution:

• Ensure screenshot is legible—even if it has to be on a separate page of the sign in sheet





## Multiple files and file formats


- Issue 1: Sites submit multiple files for sign-in sheet documentation delaying approval process
- Reason:
  - Multiple file types (e.g., WORD, JPEG, PNG, PDF, etc.) create confusion on information being documented
  - More time is required to validate these types of sign in sheets and can lead to delays to and errors upon review
  - Since February 2024, the request has been for all documentation to be submitted as a PDF

#### • Solution:

- Combine multiple file types into a singular PDF for sign-in sheet documentation
  - $\,\circ\,$  The PDF does not have to be one page
- If the meeting is hybrid—e.g., both in-person and virtual, two PDFs can be turned in for sign-in sheet documentation



 Issue 1: Date of agenda does not match the date on the sign-in sheet or on the database submission






 Issue 1: Date of agenda does not match the date on the sign-in sheet or on the database submission

#### • Solution:

• Ensure that the date on the agenda, sign-in sheet, and database match prior to submission





• Issue 2: Agenda does not note a MARCQI specific update

- Issue 2: Agenda does not note a MARCQI specific update

- Solution:
  - Ensure MARCQI is noted in the agenda directly

### **Attendee lists**

• Issue 1: Sites only have Clinical Champion and Clinical Data Abstractor attend the site-based quality meeting. The meeting is not accepted as a site-based quality meeting.

#### • Reason:

- Required attendees of a site-based quality meeting are:
  - $\odot$  Clinical Champion
  - **o Clinical Data Abstractor**
  - ${\rm \circ}\,$  Another individual involved in joint replacement care

#### Solution:

- Ensure all attendees are available and aware of site-based quality meeting date, time, and location
- Document at least the required attendees on the sign-in sheets



### **Attendee lists**

• Issue 2: MARCQI surgeon is listed in sign-in sheet but not on the existing list of MARCQI surgeons for the CDA to check off on in the database

#### • Reason:

- MARCQI surgeon will not get credit for attending the site based meeting if the CDA is unable to check off the surgeon's name from the site's surgeon list in the MARCQI database
- Only MARCQI surgeons who operate at the site receive credit for attending a sitebased quality meeting at the site itself

#### • Solution:

- Submit <u>a form to add the surgeon to the CDA account</u> prior to submitting the meeting documentation
- Alert your coordinator that you completed the <u>form</u> to add a surgeon to your MARCQI database account via <u>MARCQI.database@umich.edu</u>



### **Attendee lists**

• Issue 3: Surgeon is listed in sign-in sheet but not on the existing list of MARCQI surgeons for the CDA to check off on in the database. CDA selects "Other" and types in name of the surgeons on the sign-in sheet.

#### • Reason:

- MARCQI surgeon will not get credit for attending the site based meeting if the CDA is unable to check off the surgeon's name from the site's surgeon list in the MARCQI database
- Only MARCQI surgeons who operate at the site receive credit for attending a site-based quality meeting at the site itself

#### • Solution:

- If the surgeon in the sign-in sheet is not a MARCQI surgeon (e.g., someone who performs total hip or knee replacement surgery at your site), please do not add them to "Other" or your documentation will be rejected.
- If the surgeon in the sign-in sheet is a MARCQI surgeon, submit <u>a form to add the surgeon to</u> the CDA account prior to submitting the meeting documentation
- Alert your coordinator that you completed the <u>form</u> to add a surgeon to your MARCQI database account via <u>MARCQI.database@umich.edu</u>



### Site-based quality meeting dates

- **Issue 1**: Site was unable to conduct a site-based quality meeting submit documentation prior to the deadline
- Reason:
  - Site based quality meetings must occur in the following cadence:
    - 1<sup>st</sup> site-based quality meeting: After the 1<sup>st</sup> MARCQI Collaborative-wide meeting in the calendar year, but before the 2<sup>nd</sup> MARCQI Collaborative-wide meeting in the calendar year
      - Example:
        - $\circ$   $\phantom{-}$  2024: February 3, 2024 June 6, 2024
        - $\circ$  2025: February 8, 2025 June 27, 2025
    - 2<sup>nd</sup> site-based quality meeting: After the 2<sup>nd</sup> MARCQI Collaborative-wide meeting in the calendar year, but before the 3<sup>rd</sup> MARCQI Collaborative-wide meeting in the calendar year
      - $\circ$  Example:
        - $\circ$   $\phantom{-}$  2024: June 8, 2024 September 26, 2024
        - $\circ$   $\phantom{-}$  2025: June 28, 2025 October 9, 2025
    - 3<sup>rd</sup> site-based quality meeting: After the 3<sup>rd</sup> MARCQI Collaborative-wide meeting in the calendar year, but before November 15<sup>th</sup> of the calendar year
      - $\circ$  Example:
        - $\circ$   $\phantom{-}$  2024: September 28, 2024 November 15, 2024
        - $\circ$   $\phantom{-}$  2025: October 11, 2025 November 15, 2025

- Solution:
  - Schedule site-based quality meetings as soon as meeting dates are announced to hold the time on the Clinical Champion and surgeons' calendars
  - Ensure the clinical champion is aware of the timelines needed for the site-based quality meetings



### Site-based quality meeting dates

• Issue 2: MARCQI surgeon was unable to attend scheduled site-based quality meeting, and Clinical Champion would like to have a 1:1 site-based quality meeting with the MARCQI surgeon

#### • Solution:

- CDA does not need to attend the 1:1 site-based quality meeting if the main site-based quality meeting occurred prior to the 1:1 meeting with the MARCQI surgeon and MARCQI Clinical Champion
- Sign in sheet and agenda for 1:1 site-based quality meeting is required
